

## Policy Proposals for 2014 State Legislative Agenda

Each summer and fall, the Housing Alliance engages in a process to set our state legislative agenda for the upcoming session. Using any unfinished priorities from the previous agenda as a starting point, we work together with our members to determine our shared priorities. Part of this process includes considering priority or support agenda proposals brought by members.

## The Housing Alliance Agenda Setting Process

The Housing Alliance's Public Policy Committee is comprised of members who have committed to being more deeply involved in our state and federal legislative work. They work with Housing Alliance staff to develop our priorities and make a recommendation to the Housing Alliance's Board of Directors.

This year, the Public Policy Committee will meet on Monday, September 9 to discuss and vote on the 2014 Housing Alliance state legislative agenda recommendation. This meeting is open to all members. - Has a balance of policy and fiscal asks.
- Addresses the spectrum of housing needs.
- Addresses urgent issues.
- Builds relationships, brings in partners, and builds the movement.
- Meets the Housing Alliance's short-term and long-term policy objectives.

1. Describe the legislation. Please explain the problem the bill addresses. What law(s) will it create or amend, and how it will be implemented and enforced? Please attach a copy of the policy proposal or the current language of the proposed bill. If you are attaching language from a previous session, please note if you intend significant changes to the language.
2. Which Housing Alliance agenda is this submission for? Each year, the Housing Alliance has both a "priority" and a "support" agenda. The priority agenda represents bills and fiscal asks that the Housing Alliance will take the lead on. The support agenda represents bills that the Housing Alliance will advocate for, but which are led by another organization.
3. How developed is your proposal? If the language is not yet finalized, when do you expect it to be?
4. Could this policy bring new partners and allies into the affordable housing movement?
5. Who are the stakeholders and organizations interested in this legislation?
6. Are you working with a coalition on this legislation? If so, what decision-making power do you have over the language and strategy? Who else is a decision-maker?"
